

## Invitation for Bids

- 1. PT. Geo Dipa Energi (Persero) ("the Employer") has received financing from the Asian Development Bank (ADB) toward the cost of **Geothermal Power Generation Project**. Part of this financing will be used for payments under the contract named above. This contract will be jointly financed by Japan Fund for the Joint Crediting Mechanism. The eligibility rules and procedures of ADB will govern the bidding process.
- PT. Geo Dipa Energi (Persero) ("the Employer") invites sealed bids from eligible Bidders for the construction and completion of the EPC Geothermal Power Plant Patuha Unit 2 ("the Facilities").
- 3. **Open competitive bidding (International Advertisement)** will be conducted in accordance with ADB's <u>Single-Stage: Two-Envelope</u> procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
- 4. Only eligible Bidders with the following key qualifications defined in the bidding document may participate in this bidding:

  - The meeting point will be at PMU Head Office Project-PT. Geo Dipa Energi (Persero), Jl. Akses Tol Soroja Blok Sukamanah Parung Serab, Kecamatan Soreang, Kab. Bandung 40914, Jawa Barat, Indonesia at 9:00 hours (Western Indonesian Time) at the same date. Bidders must provide their transportation vehicle and personal protective equipment standard (PPE, safety shoes, and helmet) for their personnel.
  - Site Visit will be conducted with all the COVID-19 protocols. The Employer will provide Journey Management Plan and Site Plan to the Bidders.
